#### 1. Register for State Withholding Tax

We should be listed in the drop down list as Payroll City. Enter Payroll City's TPA ID (500003462) and assign the following roles:

- Edit Employment Wage Detail
- View Rate Notice and Voluntary Contribution
- Edit Tax Payments Update and Submit
  - \*Please note that at this step you will be able to view your current rate for unemployment. You will need to submit this to payroll city in step 5.

#### 4. Register for FAMLI
